Requested Start Date:

1. Determine which 'Application Request Received By' date you will successfully meet to determine which 'MSDC Approval to Send Application' meeting your request will be presented. Pending approval the application will be sent to the applicant within 2 business days of the meeting.
2. Then determine which 'Complete Application Submitted by' date the application and all supplemental documents will be submitted by, and then select a requested start date that falls within the Temporary Privileges column or after MSDC (Board Approval) column.

* Per SCH Credentials Policy temporary privileges may only be granted after Credentials Committee positive recommendation, President of Medical Staff and Chief Medical Officer approval. Per TJC temporary privileges may only be granted prior to Medical Executive Committee review and recommendation.

Credentials Policy 3.A.7: Once an application is deemed complete, it is expected to be processed within 120 days, unless it becomes incomplete. This time period is intended to be a guideline only and will not create any right for the applicant to have the application processed within this precise time period.
